

Any person that issues a check that is returned for non-payment, will be equired to pay a fine of \$25.00 per check and all items with which check or checks were issued shall then be paid by cash, money, or cashier's check.

CONDITIONAL, UNSIGNED, INCOMPLETE ENTRIES received without fees will not be accepted.

OWNERS ARE RESPONSIBLE for errors on entry blanks and for entering the same dog twice. No refunds for duplicate entries. ENTRIES NOT ON OFFICIAL AKC FORMS or photocopies of entry forms without rules and agreement on reverse side of Official AKC entry form are NOT acceptable.

CHANGES, ADDITIONS, CORRECTIONS OR CANCELLATIONS to entry forms must be received in writing by U.S.Mail, Telegram, or by FAX, Signed and Dated by Owner or Agent prior to the close of entries. Not acceptable by Telephone. ENTRIES MUST BE SUBMITTED with required entry fee on an Official American Kennel Club Entry Form. Entries submitted in the form of telegrams or by telephone, cannot be accepted.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by Judge, or barred from competition by action of the show committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entries fees for duplicate entry or overpayment of entry fees. If because of riots, civil disturbances, fire extreme and/or dangerous weather conditions, and Act of God, public emergency, act of a public enemy, strikes or another acts beyond the control of the Club or Show Secretary it is impossible to open or complete the show, no refund of entry fee will be made.

AN ADMINISTRATIVE FEE of \$2.00 will be charged for all cancellations or changes made prior to closing of entries.

ONLY DOGS THAT ARE ELIGIBLE to be shown under the American Kennel Club rules shall be allowed on the show grounds and dogs excused form further judging are to be removed promptly.

ALL DOGS SHALL BE held on leash or confined to their crates, except when being judged or when being exercised.

THERE SHALL BE NO drilling nor intensive or corrective training of dogs on the show grounds or premises.

DOGS MUST BE READY FOR JUDGING. The Club and its Show Secretary will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

DOGS NEED TO BE AT THE SHOW only at scheduled time for judging and may leave immediately thereafter, unless require for further judging

THE CLUB reserves the right to substitute a prize of equal or greater value,

ALL TROPHIES must be claimed the day of the show. None will be mailed or otherwise distributed.

CLASS CASH PRIZES will be paid in the ring to the persons showing the dog. Claims for prize money must be made in the ring before the judging of that Breed is over and the Show Secretary's Office is advised at once. The Show Secretary and Show giving Club disclaim any liability for cash prizes after the judging of the Breed is over.



LIMITED OVERNIGHT PARKING

Parking is solely at the applicant's own risk. The applicant by submitting this application waives any and all claims and causes of action against Western Hound Association of So. Cal. DIRECTIONS TO THE SHOWGROUNDS

FROM THE NORTH: Take most convenient freeway to the 55 freeway. Exit at Chapman Avenue EAST. Chapman Avenue turns into Santiago Canyon Road. Follow the road approximately 9 miles (from 55 freeway). You will pass Irvine Lake on the left (DO NOT turn into Irvine Lake). Make first left after Irvine Lake at park entrance. Follow signs.

TOLL ROAD OPTION: From 91 Fwy, take 241 Fwy. (toll road). Exit Santiago Canyon Road and go

left. You will pass Irvine Lake on the left (DO NOT turn into Irvine Lake). Make first left after Irvine Lake at park entrance. Follow signs. FROM THE SOUTH: Exit 5 Fwy North at El Toro Road-go right. El Toro Road turns into Santiago Canyon Road. Follow road 15.75 miles to park entrance on the right. If you reach Irvine Lake, you've gone to far. Make right turn at park entrance Follow signs.

TOLL ROAD OPTION: From 5 or 405 freeway, take 133 Fwy North. 133 turns into 241 Fwy (toll road). Take 241 North, exit Santiago Canyon Road and go right. (you will pass Irvine Lake on the left DO NOT turn into Irvine Lake). Go approx. 1/8 mile. Turn left at park entrance.

BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owners records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

GRAND CHAMPION SELECT

When quality warrants, after BOB and BOS are awarded, a Select Dog (SD) and Select Bitch (SB) may be chosen from the remaining Champions (Non Regular Class winners that are Champions and Qualify for BOB are eligible) - (WD or WB are not eligible) (AKC Dog Show Rules, Chapter 3, Section 14 Effective 5-12-10)

(BBE) CLASS ELIGIBILITY

All dogs entered in the Bred-By Class must be individually registered with the AKC.

The person handling the dog must be a breeder of record of the dog and an owner of record of the dog.

Family members must be both a breeder and owner of record to exhibit in the class.

AWARDS OF MERIT

The Western Specialty often has a number of quality Pharaohs in competition exceeding the number of top awards available. After Best of Breed, Best of Opposite Sex, and Best of Winners have been awarded, the judge at his/her discretion may award all or none of the Awards of Merit offered. (The number of Awards of Merit offered is determined by the total number of Pharaoh Hounds entered in the Best of Breed class, with **one** Award of Merit available for each **seven** Pharaohs entered in Best of Breed.) An Award of Merit acknowledges those Pharaohs who were considered, indicating the judge's recognition of an exceptional specimen of the breed.

BEST PUPPY CLASSIFICATIONS

The Best Puppy competition will be for winners of the Puppy Dog and Puppy Bitch 6-9 and 9-12 regular classes only. Dogs over 12 months of age are not considered puppies. Judging will take place after the Best of Breed competition and after the Stud Dog and Brood Bitch classes.

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

Veteran Dog and Bitch - Out of respect for those veterans who honor us with their presence, only first place will be awarded in each class. All others will be considered runners up and will receive a second place designation.

Coursing Dog and Bitch – Classes are for Pharaohs who are AKC registered and are confirmed Field Champions or Coursers of Merit. NOTE: Exhibitors must supply proof of eligibility for this class with the entry. (A copy of the certificate awarding the title or a copy of the ENTIRE PAGE from either the AKC Gazette or FAN Magazine publishing the title will be accepted as proof.) Dogs/Bitches will not be entered in this class without proof of title accompanying the entry form.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

NOTE: As the judges' decision in the Stud Dog/Brood Bitch Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class.

*Stud Dog Class - For Stud Dogs with two of their get. Stud Dogs must be entered in the Stud Class and must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed competition, or some other Non-Regular class.

*Brood Bitch Class - Same as Stud Dog Class, except replace "Stud Dog" with "Brood Bitch" and "Get" with "Produce". *Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class".

PHARAOH HOUND SWEEPSTAKES

Sweepstakes will be judged prior to the regular breed classes. Entries are open to nonmembers as well as members. All entries must be made at the same time as the regular class entries and on the same form with specific age division written in the "Additional Class" place on the entry form. Each Pharaoh in Puppy Sweepstakes must be entered in a regular class. Each Pharaoh in Veteran Sweepstakes need not be entered in another class.

Champions of Record are not eligible in Puppy Sweepstakes. Champions of Record are eligible in Veteran Sweepstakes.

Spayed and neutered Pharaohs are eligible in Veteran Sweepstakes only.

Classes (divided by sex): **Puppy Sweepstakes** – 6-9 months, 9-12 months, 12-18 months. **Veteran Sweepstakes** – 7-10 years, 10-12 years, over 12 years.

SWEEPSTAKES PRIZES:

The division of money will be as follows: 80% of the Sweepstakes fee becomes the Sweepstakes Fund, 20% is retained for expenses. Each class portion of the Fund will be divided among the winners as follows: First prize 40%, Second prize 30%, Third prize 20%, Fourth prize 10%.

INTERMEDIATE - A boy or girl who are at least 12 years old and under 15 years old on day of the show.
