TIMES AND ELIGIBILITY

TEST/TRIAL HOURS: 1:00 pm until completion
ROLL CALL: 12:00 pm for Tests and Trial (Immed. following conformation)
INSPECTION: At Roll Call, with early inspection starting ½ hour prior for crew
DRAW: Immediately follows Trial Roll Call

ELIGIBLE BREEDS AND REGISTRY: Only purebred Pharaoh Hounds may be entered.

LURE COURSING TESTS

JC TEST RUNS: Open to all hounds of an eligible breed. A hound running alone shall receive a certification from a Judge on one date and a second certification from a different Judge at a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

BENCH STAKE: A Pharaoh Hound that is entered in one of the regular stakes and is an AKC, CKC, UKC or ASFA-approved International show champion of record. A copy of the hound's championship certificate must accompany each entry.

QC TEST RUNS: Open to all hounds of an eligible breed. A hound at least 12 months of age (Qualifying Hound) running with another hound of the same breed or another breed with a similar running style (Testing Hound) shall receive certification from a licensed judge, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption. **The handler presenting the Qualifying Hound shall be responsible for providing the Testing Hound for the qualifying course**

LURE COURSING TRIAL

OPEN STAKE: Open to Pharaoh Hounds that have obtained an AKC Qualified Courser Title. Hounds that are disqualified from AKC Field Trials may not be entered. **SPECIAL STAKE:** Open to hounds that are eligible to enter the Open Stake and have earned their AKC Field Champion Title.

OPEN VETERAN STAKE: Open to hounds that are eligible to enter the Open or Special Stakes and have reached 6 years of age on the day of the trial.

SINGLE STAKE: Open to hounds approved to participate in AKC lure coursing trials. Hounds with breed disqualifications are eligible to enter.

KENNEL STAKE: For any 2 hounds entered in the trial owned and living with the same owner. Total scores will determine the winner. Must be designated at Roll Call.

BREEDER STAKE: For any 2 hounds entered in the trial bred by the same person. Total scores will determine the winner. Must be designated at roll call.

GENERAL INFORMATION

- Hounds not present at the time of roll call will be scratched after a 5 minute grace period.
- Each entry will be examined at inspection for breed disqualifications.
- Bitches in season, hounds with breed disqualifications and lame hounds will be excused and have their entry fees refunded.
- Spayed and neutered hounds, without breed disqualifications, may be entered.
- Monorchid and cryptorchid hounds are ineligible to participate.
- All hounds will run twice, in trios, if possible, or braces unless excused, dismissed or disqualified.
- Each course will be reversed for the final runs and reversed again for the Best of Breed run.
- Battery powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.
- A \$5 fine will be assessed for loose hounds during courses in progress.
- Please bring your own food, shade and water.
- A portable restroom will be available.
- No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Chairman.
- Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
- PHCA assumes no liability for injury to any person or dog before, during or after the Tests and Trials.
- PHCA cannot predict the time needed to complete this event and it may last for the duration of daylight hours.

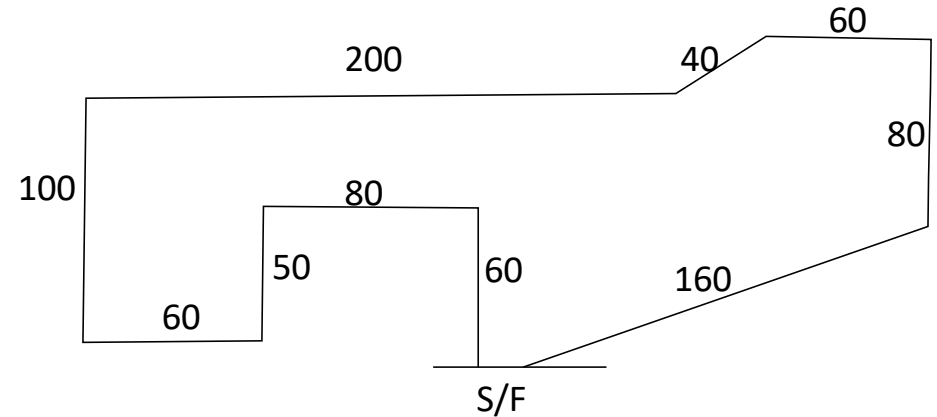
Please bring your own shade and water.
