

TIMES AND ELIGIBILITY

TEST/TRIAL HOURS: 1:00 pm until completion

ROLL CALL: 12:00 pm for Tests and Trial (Immed. following conformation) **INSPECTION:** At Roll Call, with early inspection starting ½ hour prior for crew

DRAW: Immediately follows Trial Roll Call

ELIGIBLE BREEDS AND REGISTRY: Only purebred Pharaoh Hounds may be entered.

LURE COURSING TESTS

JC TEST RUNS: Open to all hounds of an eligible breed. A hound running alone shall receive a certification from a Judge on one date and a second certification from a different Judge at a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

BENCH STAKE: A Pharaoh Hound that is entered in one of the regular stakes and is an AKC, CKC, UKC or ASFA-approved International show champion of record. A copy of the hound's championship certificate must accompany each entry.

QC TEST RUNS: Open to all hounds of an eligible breed. A hound at least 12 months of age (Qualifying Hound) running with another hound of the same breed or another breed with a similar running style (Testing Hound) shall receive certification from a licensed judge, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption. The handler presenting the Qualifying Hound shall be responsible for providing the Testing Hound for the qualifying course

LURE COURSING TRIAL

OPEN STAKE: Open to Pharaoh Hounds that have obtained an AKC Qualified Courser Title. Hounds that are disqualified from AKC Field Trials may not be entered. **SPECIAL STAKE:** Open to hounds that are eligible to enter the Open Stake and have earned their AKC Field Champion Title.

OPEN VETERAN STAKE: Open to hounds that are eligible to enter the Open or Special Stakes and have reached 6 years of age on the day of the trial.

SINGLE STAKE: Open to hounds approved to participate in AKC lure coursing trials. Hounds with breed disqualifications are eligible to enter.

KENNEL STAKE: For any 2 hounds entered in the trial owned and living with the same owner. Total scores will determine the winner. Must be designated at Roll Call.

BREEDER STAKE: For any 2 hounds entered in the trial bred by the same person. Total scores will determine the winner. Must be designated at roll call.

GENERAL INFORMATION

- 1. Hounds not present at the time of roll call will be scratched after a 5 minute grace period.
- 2. Each entry will be examined at inspection for breed disqualifications.
- 3. Bitches in season, hounds with breed disqualifications and lame hounds will be excused and have their entry fees refunded.
- 4. Spayed and neutered hounds, without breed disqualifications, may be entered.
- 5. Monorchid and cryptorchid hounds are ineligible to participate.
- 6. All hounds will run twice, in trios, if possible, or braces unless excused, dismissed or disqualified.
- 7. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
- 8. Battery powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.
- 9. A \$5 fine will be assessed for loose hounds during courses in progress.
- 10. Please bring your own food, shade and water.
- 11. A portable restroom will be available.
- 12. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Chairman.
- 13. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
- 14. PHCA assumes no liability for injury to any person or dog before, during or after the Tests and Trials.
- 15. PHCA cannot predict the time needed to complete this event and it may last for the duration of daylight hours.

Please bring your own shade and water.


There will be portable toilets available – DO NOT put poop bags in the toilet!!!


