ELIGIBLE BREEDS and REGISTRY

Only purebred Pharaoh Hounds that are one year of age or older may be entered in the regular stakes. All Entries in the regular stakes shall be individually registered with the American Kennel Club (ILP and PAL included), FCI, an ASFA recognized foreign registry or an ASFA board approved registry.

LURE COURSING TRIAL

REGULAR STAKES OFFERED

OPEN STAKE: Open to all eligible Pharaoh Hounds that have obtained an ASFA certification or an AKC Qualified Courser Certificate. Pharaoh Hounds that have earned an ASFA Field Champion title are not eligible to enter the Open Stake.

FIELD CHAMPION STAKE: Open to Pharaoh Hounds that have earned their ASFA Field Champion title.

VETERAN STAKE: Open to Pharaoh Hounds that are eligible to enter the Open or Field Champion Stakes and have reached 6 years of age on the day of the trial.

SINGLE STAKE: Open to Pharaoh Hounds including those disqualified to run in other stakes.

NON-REGULAR STAKES OFFERED

KENNEL STAKE: For two Pharaoh Hounds, designated at the time of entry, entered in one of the regular stakes, owned and kenneled by the same person.

BREEDER STAKE: For two Pharaoh Hounds, designated at the time of entry, entered in one of the regular stakes, bred by the same individual.

BENCH STAKE: A Pharaoh Hound that is entered in one of the regular stakes and is an AKC, CKC, UKC or ASFA-approved International show champion of record. A copy of the hound's championship certificate must accompany each entry.

ENTRY INFORMATION

1. All entries must be one year of age or older on the day of the trial.
2. First time entries MUST be accompanied by a copy of the dog's registration.
3. Hounds not present at the time of roll call will be scratched after a 5-minute grace period.
4. Each entry will be examined at inspection for breed disqualifications.
5. Bitches in season, hounds with breed disqualifications (except for the Single Stake) and lame hounds will be excused and have their entry fees refunded.
6. Spayed and neutered hounds, without breed disqualifications, may be entered.
7. Monorchid and cryptorchid hounds may be entered.

OPERATIONAL INFORMATION

1. Stake will be split if the entry in any one stake is 20 or more hounds at the time of the draw.
2. All hounds will run twice, in trios, if possible, or braces (except for the Singles Stake) unless excused, dismissed or disqualified.
3. Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
4. Each course will be reversed for the final runs, but the Best of Breed running direction shall be determined by the judge(s).
5. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

GENERAL INFORMATION

1. Please bring your own food, shade and water.
2. A restroom will be available.
3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
4. A \$10 fine will be assessed for loose hounds during courses in progress.
5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
7. PHCA assumes no liability for injury to any person or dog before, during or after the Trial.

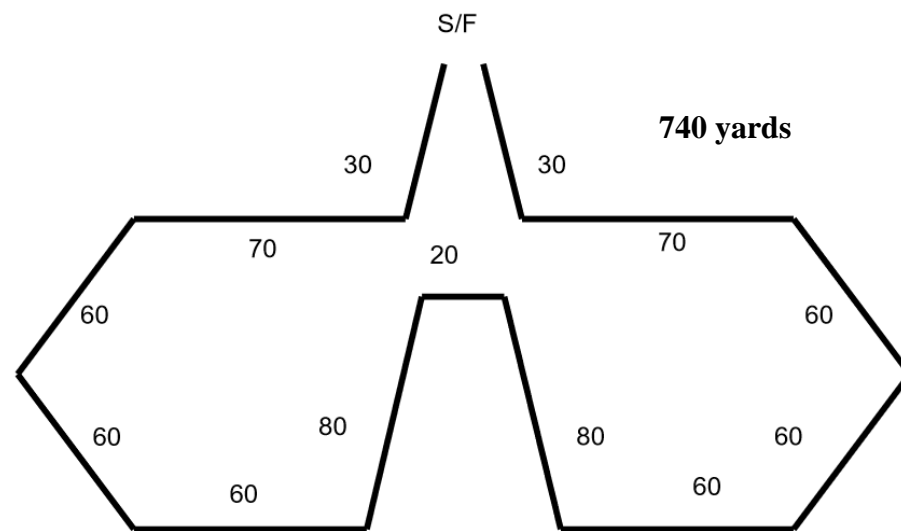

IMPORTANT ITEMS TO NOTE:

- ❖ **Bring SHADE and WATER for your HOUNDS!**
- ❖ Hounds completing an ASFA Certification are **NOT** eligible to enter the trial. Trial does NOT offer day-of entries.
- ❖ Restrooms available on-site (with running water & TP – bring your own soap.)
- ❖ Park in the asphalt parking lot, in designated spaced, next to the field.
- ❖ No cigarette smoking on or near the field. Colorado is a desert, any spark from cigarette ash could ignite the field. Please be careful!
- ❖ If you have ANY questions about what stakes/tests to enter your dog in, e-mail the field trial secretary: kdarci@yahoo.com
- ❖ Anyone exhibiting unsportsmanlike behavior will be excused from the field and may be subject to further disciplinary action.
- ❖ Weather in Colorado is unpredictable – from very hot temperatures to snow – bring rain gear, layers of clothing, hat, gloves, sunglasses, and sunscreen. It is often windy – bring stakes for your shade cloths and canopies.
- ❖ There is NO shade on the field. Bring shade and lots of water for your dogs – there is NO hose or hookup for water available at the field site.
- ❖ Some first aid supplies will be available at the field; however, you should be advised to bring your own first aid kit for your dog.
